The second selective medium for detecting the presence of Listeria monocytogenes in accordance with PN-EN ISO 11290-1:2017-07 is Palcam incubation at 37°C ± 1°C. The second selective medium for detecting the presence of Salmonella spp. in accordance with PN-EN ISO 6579-1:2017-04, Mon-EN ISO 6579-1:2017-04/A1:2020-09 is RVS broth and Brilliance Salmonella/Agar. Temperature used for incubation of  $Enterobacteriaceae: 37^{\circ}C \pm 1^{\circ}C. \ The \ temperature \ and \ incubation \ time \ of \ coagulase \ staphylococci \ used-positive: 37^{\circ}C \pm 1^{\circ}C \ for \ 48h \pm 4h.$ Temperature used for incubation of coliform bacteria: 37°C±1°C.
